### 4. First Aid Measures

Cover the affected area with emollient. Seek medical attention. Wash any contaminated clothing prior to reusing.
<b>Inhalation:</b>	Remove the victim from the source of exposure to fresh, uncontaminated air. If victim's breathing is difficult, administer oxygen. Seek medical attention.
<b>Ingestion:</b>	Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

## 5. **Fire-Fighting Measures**

<b>Extinguishing media:</b>	Carbon dioxide, dry chemical powder, alcohol or polymer foam.
<b>Special fire fighting procedures:</b>	Wear self-contained breathing apparatus and protective clothing to prevent contact with skin and eyes.

## 6. **Accidental Release Measures**

---

Steps to be taken if material is spilled or otherwise released into the environment - Wear Appropriate respirator, impervious boots and heavy rubber (or otherwise impervious) gloves. Scoop up solid material or absorb liquid material and place into appropriate container. Ventilate area and wash affected spill area after pickup is complete.
