#### **4. First Aid Measures**

<b>Skin Contact:</b>	After contact with skin, wash with generous quantities of running water. Gently and thoroughly wash affected area with running water and non-abrasive soap. <b>Inhalation:</b>	Remove the victim from the source of exposure to fresh, uncontaminated air. If victim's breathing is difficult, administer oxygen. Seek medical attention.
<b>Ingestion:</b>	Do NOT induce vomiting. Give water to victim to drink. Seek medical attention.

#### **6. Accidental Release Measures**
